## **END-USER LICENCE AGREEMENT: PREMIUM VERSION SOFTWARE** **VecTor2®, VecTor3®, VecTor4®, VecTor5®, VecTor6®, FormWorks®, FormWorks+®,** **Cyrus®, Augustus®, and Janus®**

**IMPORTANT - READ CAREFULLY:** This End-User Licence Agreement (“Agreement”) is a legal contract between you (either (a) an individual user or (b) a business organization) (“Licensee”) and the VecTor Analysis Group for Premium Versions of Software (which includes VecTor2®, VecTor3®, VecTor4®, VecTor5®, VecTor6®, FormWorks®, FormWorks+®, Cyrus®, Augustus®, and Janus®) and any associated media, printed materials and electronic documentation.

By downloading the installation package, by clicking on the “I ACCEPT” button, by opening the package that contains the Software, or by copying, downloading, accessing or otherwise using the Software, you agree to be bound by the terms of this agreement and you represent that you are authorized to enter into this agreement on behalf of your corporate entity (if applicable.) If you do not wish to be bound by the terms of this Agreement, click the “I DO NOT ACCEPT” button, and do not install, access or use this Software.

1. Purchase of the Software entitles the licensee to a non-transferable license to use the material provided in accordance with these Terms and Conditions. Licensee may not sublicense, assign, redistribute, lend, give, or transfer this License in any way.
2. The licensee acknowledges that reverse engineering, decompiling, disassembling, or attempting to discover the source code or underlying ideas or algorithms of the Software or any subsequent version is strictly prohibited. Modifications, translations and derivative works are also not allowed.

10. Premium Versions of the Software, unless otherwise contracted, carry a Group License, limiting the number of installations to 6 users. Educational versions are not to be used for Commercial applications.
